# Minutes of Parish Council Meeting held at 7.30pm on Wednesday 16<sup>th</sup> March 2022 held in Easebourne CE Primary School

#### **Councillors Present:**

#### In attendance:

- 1 Visitors' questions: None.
- **2 Apologies and Reasons for Absence:** Apologies had been received from T Baker, E Roberts Grimsey and C Sanderson due to personal reasons.
- 3 Report from District Councillor: FH had provided a report prior to the meeting. FH verbally reported that with regards to the current planning application at King Edward VII, work was on-going in relation to the limited community engagement and lack of the King Edward VII Liaison Group meetings. FH further reported that the Parish Environmental Group would meet the following week and ideas from Lodsworth, and Heyshott Parish Councils were ready to be introduced at the meeting. FH suggested that the links for support for Ukrainian Refugees which had been provided by Chichester District Council could be promoted by the Parish Council (see item 12 below).

FH left the meeting at 7.36pm and did not return.

4 Report from County Councillor: A report had not been received from Cllr T Richardson.

## 5 Chairman's Report:

MN began by thanking all those who had been involved with the Parish Design Statement (PDS) for their work, fortitude, and persistence in pursuing the necessary process, which had been very challenging. MN confirmed that it was now nearing its final stages with the document to be consulted upon in the coming weeks with the support of South Downs National Park Authority. Once adopted the PDS will become a formal planning document providing guidance which will be taken into consideration when determining the outcome of all future planning applications within the parish (see item 8d below).

MN confirmed that a contractor had been selected for the work on the War Memorial in St Mary's churchyard. It was necessary to have appropriate weather for the work to be undertaken and hoped that this would begin in early April.

Action: SH will process the Parish Council's donation for the work when bank details are received.

MN explained that consideration was being given to creating a Highway Partnership scheme with West Sussex County Council, which would allow specific highways works to be undertaken without the requirement of the County Council's permission.

MN reported that he had met with Jonathan Russell, Chief Executive of Cowdray Estate and confirmed that the estate could potentially provide wood for the public conveniences and kiosk to be constructed in Easebourne Park. Mr Russell had also confirmed that work was progressing well on the construction of the tree houses, which will be used for holiday lets, and that a resubmission of planning applications for the three sites (Cowdray Works Yard, Egmont Road and the Old School site) would take place shortly.

MN explained that the 'Midhurst Vision' group were meeting regularly to discuss 'design' within Midhurst in relation to the street scene in North Street.

MN cited that the Annual Parish Meeting would take place on 11<sup>th</sup> May 2022 and asked that Councillors consider if they would wish to volunteer for any specific roles within the Council and which Committees they would wish to serve on. The Annual Parish Meeting hosted by the Parish Council would take place on 25<sup>th</sup> May 2022 and details of how the meeting would be presented, were shortly to be discussed by the Communications group.

MN requested that any suggestions for the Parish Environmental Group were passed to ERG.

MN reported that a virtual meeting had been held with Fernhurst Parish Council and a resident, with regards to a potential Traffic Regulation Order (TRO) to reduce the speed limit on the A286 from the driveway to Cherry Tree Cottage to Kings Drive from 50mph to 40mph to increase the safety of this section of the highway. Fernhurst Parish Council had previously submitted a TRO application over a greater section of the A286 which had not be successful. As the current revised suggested section of the highway lay within the Parish of Easebourne, MN and SH would now continue to work on the resubmission of the application/new application.

MN also reported that ERG, AT and he were due to meet shortly to further discuss the signage/pointer project which will focus on gaining County Council agreement to reduce the number of standard highway signs and replace some with more aesthetically appropriate signage for the rural nature of the parish (see item 7 below).

**Declarations of interests in any matters on agenda:** IM declared an interest in relation to planning applications SDNP/21/06433 and SDNP/21/06432/FUL (see item 10 below) although this matter was for note and would not be discussed at the meeting.

# 7 Confirmation of minutes and Review of Actions:

**Action to be carried over:** IM awaiting CDC to complete a site visit and survey to assess the newly refurbished bus shelters (outside St Mary's Church and near to Conifers School) for potential litter bin installation and maintenance. There has been an on-going issue with lack of personnel at CDC to carry out site visits and surveys.

**Action to be carried over:** MN and AT to meet to discuss future-plans for managing highways related work and projects.

Action to be carried over: AT, ERG and MN to meet to discuss the 'pointers' project.

11 Queen's Jubilee Events: MN confirmed that two events would be held in celebration of the Queen's Jubilee. The first of which was a formal event in conjunction with Midhurst Town Council on Thursday 2<sup>nd</sup> June 2022 which would involve the lighting of a beacon on St Ann's Hill in Midhurst, followed by the signing of a specially composed song by the Midhurst Community Choir, and the sounding of a bugle. On Saturday 4<sup>th</sup> June 2022 from 12.00 to 16.00, a joint free event between Midhurst Town Council, Cowdray Estate and the Parish Council will be held at The Ruins, which will include the provision of refreshments, music and entertainment. Councillors will be required to support the event on the day with marshalling and litter picking.

The planting of Jubilee Trees was discussed following receipt of an email from the Easebourne Guide leader, and it was agreed that local organisations and businesses would be invited to make a donation for Jubilee trees. SH also confirmed that currently £50 from a resident was in the 'Carbon Corner' fund which could also be utilised for this project.

**Action:** Communications group to meet to discuss the publicising of the potential for local organisations and businesses to donate funds for jubilee trees.

The potential installation of a Jubilee Drinking Fountain in Easebourne Parish was also debated and IM cited a particular model which provided drinking fountains at differing heights for adults, children and dogs.

Action: IM to investigate potential drinking fountains.

- **12 Emerging Ukrainian humanitarian crises:** IM sought clarification regarding anything that the Parish Council could currently undertake in relation to this matter. MN confirmed that relevant information provided nationally and by Chichester District Council had been made available on the website. It was further agreed to support any appropriate requests received from the County Council regarding this matter.
- **13 Councillor Co-option:** MN reported that one potential candidate was unable to attend the current meeting but planned to do so at the May meeting. MN also reported that other potential candidates had shown interest in becoming Councillors.
