1. Public Question Time -

- Andy Tate (Upperfield Residents Association)
 - i. The Local Plan summary has been run through AI and there are discrepancies, including the PC comments. DK suggested feeding back to SDNPA that they did not directly ask for a stance so it seems odd to put into the report.
 - **ii.** Cowdray's response (submitted by Nova planning), they are requesting expanding the numbers and to remove the point restricting vehicular access to adjacent fields which may indicate an intention to develop further in the future. It is evident that Cowdray have also already engaged professionals.
 - iii. Upperfield Residents Association are requesting advice on next steps. Could they commission their own assessments to submit to SDNPA or could they get access to the reports that have already been submitted by Cowdray to SDNPA. Also would it be worthwhile to commission their own surveys. CS suggested contacting SDNPA to ask if the PC can view the documents and potentially set up a meeting with them regarding this particular site.
